Our goal is to benefit our family and friends within our communities – one meeting at a time.

DONATION & SPONSORSHIP GUIDELINES: The CEDA Board strives to budget as generously as possible for donation and sponsorship requests and very carefully allocates our resources to impact our communities in a positive manner while striving to assist as many applicants as possible.

DONATION & SPONSORSHIP REQUESTS MUST:

- Be submitted in writing a minimum of 30 days in advance of the event
- o Include a detailed description of the request to be funded
- Include a personalized letter of request to be addressed directly to the CEDA Board, describing individual needs, in detail - either monetary, raffle items, or both
- Be within our local communities (within 100 miles of Coarsegold)
 (exceptions may apply to Tribal Members of the Picayune Rancheria that live outside of the 100-mile radius described as local communities or any Tribes and State or National Political Organizations)
